
The Ability Center and Libbey House Foundation unveiled the completion of the project, "Restoring Accessibility to the Edward Drummond Libbey House" with a ribbon cutting ceremony on October 30. Edward D. Libbey House was the site of Opportunity Kindergarten, a school for children with disabilities operated by the Toledo Society for Crippled Children. This organization would later become The Ability Center.

Tim Harrington, Ability Center Executive Director, was a member of the first class of students at the school. The project was funded in part by a grant from the Ohio History Connection. With the completion of the project, Toledo's only National Historic Landmark is now accessible to all.

The house in Toledo's historic Old West

End was designed by noted Toledo architect David Stine and built for Edward Libbey, founder of Toledo's glass industry, and his wife, Florence Scott Libbey, in 1895.

An exterior ramp, walkway, and accessible restroom was built by Ability Center carpenters. Tim Harrington shares, "We are excited that we will get a chance to access the home again and remember our history in the Libbey House."The Ability Center



will celebrate a century of service in 2020.

#### Letter from the President

Happy New Year to OWE and all OWE friends and families! As you may have noticed...there is a new photo for this column. I am writing this as the new 2020 OWEA President. The other officers of OWEA are Chris Handley (VP), John Shaw (Treasurer) and Ann Guyton (Secretary). In crafting this, my very first column, I thought I would share some highlights about the Association as an organization, and it's philosophy regarding succession planning and term-commitments.

First let's talk about the organization. There are four officers (Prez, VP, Treas & Sec), 5 elected trustees and 6 Committee Chair Trustees that make up the OWE Association Executive Board (more on the trustees later). The four officers are elected each year along with the elected trustee(s) whose term has expired. In the last 5-6 years, we have asked the president commit to holding the position for 2 consecutive years. The thinking is that it gives the organization more stability and allows the president to be more effective as he/she'grows' into the position. Along with that, it is the hope of the executive board that the VP run for president after his/her two years as VP. Again, developing an on-going strategy of stability and planned succession. Most recently we have recommended that the out-going president hold a Trustee position for at least one year, ideally three. Okay....are you still with me?

Onto, or back to, the Trustees. As I mentioned above, there are 5 elected Trustees and 6 Committee Chair Trustees. So ultimately there could be 15 people on the executive board, 11 Trustees and the four officers. However, an elected trustee can also be a committee chair trustee. So one person could have two Trustee positions, however, they only get one vote. Our goal is to have 11 unique trustees on the Board. We are still working towards that. In summary, whether elected or appointed, all trustees have the same voice on the executive board.

We talked about term-commitments for officers let's talk about term-commitments for Trustees. Bear with me as this gets a little confusing... Elected Trustees commit to a 3-year term that expires in staggered years. In 2020, there were 2 trustee positions whose 3-year term expired: Tanasio Loudermill and Jeni Belt <u>Tuesday, Jan. 14, 2020</u>

were elected into those open positions. The other three elected Trustees are: Deb Kienzle, Sue Postal, and Dan Schmitt, in varying stages of completing their 3-year terms. The six standing committee Trustees are: Arboretum, Business/Networking, Education, Festival, NB&I and Preservation. The Committee Chair/ Trustees are: Kent Illenden (Arboretum), Stas Krukowski and Riordan Glynn (Business Networking), Deb Kienzle (Education), Jeni Belt (Festival), Scott Ramsey (NB&I Fund), and Sue Postal (Preservation). They are appointed by the president and approved by the Board and they don't have any term commitments with regards to our by-laws, but obviously we would like them to commit to a multi-year appoint-

I am looking forward to my new role. I have been impressed with the past presidents of the Association and I know I have big shoes to fill. My goal is to continue the momentum of ensuring the Association reflects and represents the entire Old West End neighborhood and continue to make the OWE a great place to live.
