Dear Old West Enders,

Who was the first person who welcomed you to the neighborhood? Who called you up onto their porch or invited you inside to see a home of which you had not yet dreamed? Who helped orient you to Festival and to the patterns of life peculiar to the OWE, renting golf carts, applying for COA's, and attending Music in the Park?

My introduction to the neighborhood came through Michael Loomus, a man with terrific taste in music, locally sourced foods, and beards. When I first interviewed with the Call Committee at Glenwood Lutheran Church, I told them they did not need to find a place for me to stay; I would reserve an Air BnB in the neighborhood and get to know the area. I think this might have been one of the finest decisions of my life because Michael was that first host.

Michael's enthusiasm for this neighborhood was completely infectious. When he realized that I had no idea what made the Old West End special, he helped me understand both the age and grandeur of the Houses, which he knew from years of volunteering as a house guide. (He would go on to be a House Co-Captain for the Bartley Mansion that year.) Then he regaled me with other legends from the Old West End Festival; this magical time when the whole neighborhood erupted with joy and golf carts. He also observed that the usual social barriers between strangers become transformed by the energy of the Festival. He marveled at how many people he had met at Festival, wandering from porch to porch, who had become really important to him. In May 2017, I moved to Toledo to begin a call as the Pastor of Glenwood Lutheran Church. When I got to experience the magic for myself in the 2017 Festival, Michael was there to invite me to live jazz on the balcony of his apartment and continued to get me networked into the neiahborhood.

tors, and potential neighbors, might have such a terrific introduction. Michael showed me things that I still think being an Old West Ender is all about: a sense of wonder around stunning architecture and the stories of these houses, a willingness to volunteer in Festival and beyond, and a commitment to meeting new people and starting new dialogues. His excitement fueled my excitement, his recommendations guided my celebration of Festival, and his hospitality solidified me as a neighbor with new relationships of my own in this place.

The OWE Association has committees to which grant responsibility for our most important work: Security, Preservation, the Steering Committee of Festival, Education, and the Arboretum. I wonder whether it would be wise for us to have a dedicated team that welcomes people to the neighborhood and introduces them with the same kind of care and enthusiasm that Michael Loomus shared with me. Indeed, even preservation begins with a person's introduction to neighbors who will show them the ropes and help them avoid mistakes learned through experience. I will never be able to thank Michael enough for that, and I hope that anyone who moves to our home might have their Michael Loomus, and perhaps you will be that for someone new this month. 

CONSENT DECREE: PRESERVING THE OLD WEST END HISTORIC DISTRICT

If you have been reading this series of articles** about the Court Ordered Creation of the "CONSENT DECREE" between the residents of the historic districts and the City of Toledo it should be clear that the future of the historic districts within the City of Toledo is uncertain.

Repeatedly, the City of Toledo has been brought back to Court by OWE residents and neighborhood groups to enforce the Toledo Municipal Code legal mandate of the Historic District Zoning Overlay Ordinance. Equally, however has been the problem of residents of the historic district who have knowingly violated the Historic District Overlay Ordinance for personal convenience and gain even if said actions may lead ultimately to the destruction of the historic districts.

An example, is the resident or property owner, who is **aware** of the necessity to consult with the Old West End Historic District Commission (OWEHDC) and receive a Certificate of Appropriateness (COA) "before" any environmental change is made to a property within the historic district **but chooses** to remove, change or destroy, and then blatantly claim ignorance of the law.

An "environmental change" is defined as: any exterior alteration, demolition, removal or new construction of any property, requiring or not requiring a building permit subject to the historic overlay provisions of the Zoning Code. (Ch. 1103.0302)

"Alter" or "alteration" is defined as: any change requiring a building permit involving the exterior architectural features, including significant landscaping, or any property which lies within a hist-oric district, not including demolition,removal or new construction. (Ch. 1103.0302).

Unfortunately, there are too many examples past and current of this recurring phenomena. I will, due to limitations of space, just list two as examples.

November 13, 2018 REF: OWE-107-18 Robinwood Avenue. The applicant received a COA to replace the existing concrete driveway, rear entry steps, and walkway patio at the subject site. During the September 9, 2018, OWEHDC public hearing meeting there was detailed discussion, with no mention of any foundation work. The applicant carried the "stamped concrete design" pattern onto foundation work that was not requested or

approved via OWE-74-18. The applicant then wanted and sought a "retroactive approval" of the work which was denied.

KeyBank, which has a branch at 3031 Collingwood Blvd., had a contractor knock down a brick wall next to the bank, May 2019, without seeking any COA. In so doing, it violated the Toledo Municipal Code, which requires that any structure removed in the Old West End Historic District is demolished "after" the OWE Historic District Commission has issued a certificate of appropriateness (COA). Rather than require the restoration of the wall for violating the Historic District Overlay Ordinance, the bank was allowed to pay a small fine and then the City granted a retroactive COA in violation of the Consent Decree, and then erect a fence. So, those who ignore the law are rewarded!

(The city did have recourse but chose not to take it:) Toledo Municipal Code states:

TMC 1115.0505 Abatement. The City may seek a court order in the nature of mandamus, abatement, or other action or proceeding to abate or remove a violation or to otherwise restore the premises in question to the condition in which they existed prior to the violation. (Ord. 336-15. Passed 6-23-15.)

Above are just two, of too many, salient examples of residents and property owners who want the status of living within a historic district without the incumbent personal responsibility of living in a special community.

In conclusion, the final chapter of historic preservation is the action taken by each resident and property owner choosing to either preserve or personally profit from the historic district. Old time residents of the historic district can relate sad stories of exterior stained glass windows illegally removed and sold. In one case on Delaware subsequently recovered and replaced only later by another owner of the property. Then a sub-sequent owner removing and selling them yet again. Another piece of the historic fabric lost.

Time, decay, fire, and neglect all take a toll. It

is not always possible to replace and maintain the structures we have in this neighborhood. Protecting and preserving the Old West End Neighborhood is not an easy or inexpensive task. Remember that the Old West End Historic District Overlay Ordinance only protects and preserves the exterior historic district elements and that is actually only a process of discussion, evaluation, recommendation and compromise.

THE CHOICE IS YOURS:


Ultimately, do you consider your-self and time in the Old West End as that of a guardian and caretaker of a legacy, or that of an opportunist? Many of the wonders that once were in this historic district lost through attrition, are now unappreciated by those here today, because they are unaware of what preceded their time in this neighborhood.


