On Saturday, February 12th, I met with **OWE Association Board Members Chuck** Madrigal and Andrew Larsen to discuss a process for welcoming new people to the neighborhood. The Women of the Old West End spearheaded a project to put together a thorough welcome packet, and the three of us were going back and forth about how to utilize these packets.

As the conversation went on, we realized that the Historic District kept coming up as an important component of someone's introduction to the Old West End. Whether or not someone lives in the Historic District proper, or outside it while still in the Old West End, we agreed that all Old West Enders should have familiarity with what it means to preserve a house, with the municipal code related to a Historic District (which Dave Neuendorf helpfully included in February's newsletter), and with the process for working on a 'historic' home. (That is, applying for a Certificate of Appropriateness before the Historic District Commission.) How do we introduce new neighbors to the practices of keeping the appearance of our whole neighborhood distinct and spellbinding? On the one hand, the intensity of these unique, DIY projects and the lore of attempts to preserve these homes knits us into a community that shares common problems and solutions. On the other hand, sometimes preservation becomes prioritized over people which undermines the Association's mission to create a harmonious community. As the OWE Association, based on the discussion of our February meeting, it appears to me that we would rather live in a community of problem-solvers, working together to preserve the whole neighborhood in more than its architecture.

Andrew, Chuck, and I wrapped up our meeting about half past noon, and then less than an hour later I received a notification on my phone from the Blade: Old West End Shooting. You know the story. A

driveby shooting resulted in DaMia Ezell's death. At first I fixated on this title, an Old West End shooting. I recoiled because that seems like an odd way to name this: like what makes something an Old West End shooting? Is that an effort to tell a story that 'the Old West End is becoming less safe!' If so, I don't buy it and I wish the Blade would tell a more accurate story about us. However, you all made it an Old West End shooting with your compassion. It happened in the Old West End and so we've responded, as best we can. Kristin, the Black Kite's owner, was at the vigil for DaMia along with me and several other neighbors. A neighbor, Melanie coordinated with the social worker at Glenwood Elementary and with many of you to deliver stuffed animals to the kids who were most affected by this tragedy. You've raised money for the family's expenses and claimed them as your neighbors. We are continuing a conversation about what being secure in the Old West End means. (When I am writing this our twice rescheduled conversation about safety has not yet occurred.) In this instance of tragedy, you all led with love and not fear. I'm proud to be your neighbor and to be in the on-going dialogue of how to preserve homes, keep each other safe, and have the most fun doing it.

Consent of What?

The article this month is about the necessity for a Court ordered "Consent Decree" between the residents of the Historic Old West End and the City of Toledo. Sadly one cannot make litigation sound exciting since the devil is found in the details.

The Old West End Historic District was created by Ordinance 399-80 Passed 6-10-1980.

The District is one of the City's Historic Overlay Districts as defined in 1103.0300 | -HO, Historic Overlay Districts 1103.0301 purpose of the Toledo Municipal Code (TMC). The Municipal Code contains restrictions on "environmental changes" to buildings in historic districts, the guidelines to be used by the Historic District Commission, and the procedures to be used by homeowners seeking to make changes (TMC.1111.1100). The first devil found in the details is TMC Historic District definitions.

TMC 1103.0302 Definitions.

The definitions of this section are to be used solely for the purpose of interpreting and administering the Historic District and landmark provisions of this Zoning Code.

A. "Alter" or alteration" means any chance requiring a building permit involving the exterior architectural features, including significant landscaping, of any property which lies within a Historic District, not including demolition, removal or new construction.

B. "Applicant" means any person, persons, association, organization, partnership, units of government, public bodies and corporations who applies for a Certificate of Appropriateness in order to undertake an environmental change within a Historic District or to a landmarked property.

C. "Certificate of Appropriateness" means a certificate authorizing any environmental change within a Historic District or to a landmarked property. D. "Delegates-at-large" means residents of Toledo appointed to the Historic District commissions who represent education, civic, governmental, professional and historic preservation organizations.

E. "Demolition" means the complete or substantial removal or destruction of any structure which is located within a Historic District or on a landmarked property.

F. "Environmental change" means any exterior alteration, demolition, removal or new construction of any property, requiring or not requiring a building permit subject to the historic overlay provisions of this Zoning Code. (Ord. 314-12. Passed 6-19-12.)

G. "Exterior Architectural Feature" means the architectural style, general design and arrangement of the exterior of a structure including, but

not limited to, the type, color and texture of the building material, doors, windows, roof, porches and other appurtenant features.

H. "Historic District" means any district that has been locally designated by the City Council to be regulated by the historic overlay provisions of this Zoning Code.

For your information, I quote from the Plan Commission records:

After the creation of the Old West End Historic District it wasn't long before OWEHD residents found that the City Of Toledo was ignoring the historic district requirements and so the Old West End Association found itself in Common Pleas Court, Case Number 82-0447 seeking relief. Relief which was granted to the neighborhood by way of a "Consent Decree" where the City of Toledo was court "ORDERED" to enforce the law.

Common Pleas Court Case No. 82-0447 Judgment Entry of 5/05/82;

The Case arose out of the City of Toledo lifting (putting an end to) a stop work order for aluminum siding installation on a house on Scottwood in the Old West End. The city was enjoined (prohibited by judicial order) from any further violations of Part 11- Zoning and Planning, Chapter 1153 Historic Overlay Districts of the Toledo Municipal Code. Various administrative procedures were set forth.

Of most importance, the CONSENT DECREE ORDERED that the Defendants (City of Toledo and successors in Office) are to enforce the law: "2.) No environmental changes shall be made to any property within a historic district in the City of Toledo unless a Certificate of Appropriateness has been previously issued by the appropriate Historic District Commission." (As an aside, the City was ordered to PAY the costs of the Plaintiff-The Old West End Associa-

tion - including attorney fees; and "This Court shall retain continuing jurisdiction of this action to ensure compliance with this ORDER and will entertain further requests for injunctive relief brought by any party to restrain further violations of Chapter 9, Article XXVIII of the Toledo Municipal Code.)"

Many neighbors have heard of that animal called a "Consent Decree" but really don't understand what it means. This is a Wikipedia explanation.

Consent Decree: A consent decree is an agreement or settlement that resolves a dispute between two parties without admission of guilt (in a criminal case) or liability (in a civil case), and most often refers to such a type of settlement in the United States. The plaintiff and the defendant ask the court to enter into their agreement, and the court maintains supervision over the implementation of the decree in monetary exchanges or restructured interactions between parties. The decree issued by consent cannot be modified, except by consent. Typically, a consent decree dispenses with the necessity of having proof in court, since by definition the defendant agrees to the order. Thus, the use of a consent decree does not involve a sentence or an admission of guilt. The judge can only step in to assist in enforcement if a party complains to the court that an opponent has failed to perform as agreed."

Unfortunately, the residents of the OWE have had to return to the Common Pleas Court regularly to get the City of Toledo to enforce the TMC Historic District Overlay Ordinance. The Old West End Association found itself back in the Court of Common Pleas in 1985.

Judgement Entry of 11/22/85

The Case arose out of replacement windows at the American Red Cross building in the Old West End and the demolition without a Certificate of Appropriateness of several structures in the Vistula Historic District. Additional administrative procedures were established and certain notifications were required.

(The city was once again ordered to enforce the Historic District Ordinance and agreed to further conditions to enforcement, example: "Notification of residents." As an aside, the city was again ordered to pay the costs of the Plaintiff - The Old West End Association, including attorney fees. Of interest to me was a Supplemental Judgement Entry of 11/22/1985.)
